SCHOOL OF PHARMACY AND HEALTH PROFESSIONS
RECOMMENDED STUDENT DRESS CODE

This dress code was developed by students for students. The appearance of students enrolled in the School of Pharmacy and Health Professions (SPAHP) is expected to project a professional image for the School. The following recommendations are intended to promote a professional and productive learning environment for students in the classroom. A dress code for special events, laboratories, and clinical experiences may be established by the School, an individual program, or an individual instructor. If a student has any questions about certain aspects of the SPAHP Dress Code, he/she should contact the Director of Student Affairs in the Office of Academic and Student Affairs.

Tops:

- No tube, halter, see through, spaghetti strap, or revealing tops.
- No bare midriffs.
- No inappropriate logos or language that may be offensive to others.
- No holes, rips, or tears.

Bottoms:

- No low rise pants where skin or undergarments will show.
- No boxer shorts as an outer garment or short shorts.
 - No shorts higher than 2 inches above the knee.
- No pajama pants or sweat pants.
- No holes, rips, or tears.

Shoes:

- No holes, rips, or tears.

Miscellaneous:

- Hair (including facial hair) is to be neatly trimmed and styled. Length may be individualized but no extreme looks are allowed. No unnatural hair colors are allowed (e.g., blue, green, pink, etc.).
- Fingernails are to be neat, clean, and well maintained.
- All visible tattoos need to be covered. All visible body piercing/adornments (other than in the ears) are not permitted to be worn during classroom hours, including nail, tongue, eyebrow, nose, lip or any other facial piercing/adornments. Visible ear adornments are limited to three per ear. All unapproved piercing/adornments must be removed while in the classroom. Body piercing/adornments

are acceptable when part of religious or cultural dress.

- No hats or caps in the classroom, except when a part of religious or cultural dress.

Members of the Pharmacy and Health Professions Student Government (PHPSG) Board, Academic Class Officers, and Student Organization Officers are responsible for promoting the dress code and encouraging compliance with it. If a student is consistently noncompliant with the dress code a faculty member may be asked to complete a Professional Behavior Citation Form and follow the procedures outlined in the School's Professional Behavior Policy (available at <http://spahp2.creighton.edu/oasa/OASA%20Home.aspx>).
